1 Academic v. Commercial use

The user may **only** use CCDb for academic research. It is prohibited to use the database for any *non-academic* purpose. Non-academic purposes, we define to include, but are not limited to:

- proving the efficiency of commercial systems

- using screenshots of subjects from the dataset in advertisements
- selling data from the dataset

- developing governmental systems used in public spaces

2 Responsibility

This document must be signed by a person with a permanent position at an academic institute (the signee). Up to five other researchers affiliated with the same institute for

whom the signee is responsible may be named at the end of this document which will allow them to work with this dataset.
